In connection with a proposed purchase of assets by Molina Medical Management, Inc., Midwest Medical Center desires to transfer License No. 21-26168-01 to Molina Medical Management, Inc., effective upon the Commission's approval of this request.

- The Radiation Safety Officer and Authorized Users will remain the same, as listed
  on the Midwest Medical Center NRC license <u>21-26168-01</u>. In addition, there will
  be no changes to the management who have control over licensed activities.
- 3. There will be no other changes to the organization, location, facilities, equipment, or procedures that relate to the licensed program.
- 4. All required records regarding the use and possession of licensed materials will be current at the time of the transfer. The status of compliance will be maintained before, during and after the transfer of ownership. The surveillance program is current and documented. All records are kept at the address of use. The surveillance program will continue to be up to date at the time of the transfer of control.
- 5. Midwest Medical Center confirms that all records concerning the safe and effective decommissioning of the facility, pursuant to 10 CFR 30.35(g), 40.36(f), 70.25(g), and 72.30(d); public dose; and waste disposal by release to sewers, incineration, radioactive material spills, and on-site burials, will be transferred to the new licensee, as licensed activities will continue at the same location.
- 6. The transferee commits to abide by all constraints, conditions, requirements, representation, and commitments identified in the existing license.

All parties involved with the transfer are aware and agree to the planned transfer of ownership.
