


PROGRAM SCOPE

This was a routine, unannounced inspection of a cancer treatment clinic authorized to conduct medical procedures permitted by 10 CFR 35.300 and 35.400. The licensee administered approximately one iodine-131 treatment per year and released all patients in accordance with 10 CFR 35.75. The licensee staff also performed temporary cesium-137 implant procedures using cesium-137 tubes stored at Prime Healthcare Services - Garden City, authorized by NRC license 21-04072-01. Two temporary cesium-137 implants were performed since the last inspection.

The inspector reviewed a selection of licensee documents, including written directives, patient release criteria, package receipt logs, and dosimetry. In addition, interviews with the staff regarding potentially contaminated packages, patient surveys, and patient release instructions indicated adequate knowledge of radiation protection principles.

Note to inspector: Prime Healthcare Services - Garden City, 6245 North Inkster Road, Garden City, MI, 21-04072-01, 030-02036, should be inspected concurrently with Radiation Therapy Associates, P.C..

No violations were identified during this inspection.
