In response to the Office of the Inspector General's (OIG) memorandum dated July 14, 2015, provided below is the status of Recommendation 1 in the Audit of the Nuclear Regulatory Commission's (NRC) Sequestration Process (OIG-14-A-20).

Recommendation 1:

OIG recommends that the Executive Director for Operations and the Chief Financial Officer collaboratively establish agencywide guidance for future sequestration planning activities and reductions.

Response:

Agree. The Office of the Chief Financial Officer and the Office of the Executive Director for Operations have developed three levels of agencywide guidance for future sequestration planning activities and reductions, including the process for determining how the sequester reduction will be applied across NRC programs and how the sequester funding plan will be developed.

The first two levels, the Sequestration Planning Guidance (Agencywide Document Access and Management System (ADAMS) Accession No. ML16285A004) and the Fiscal Year 2016 Sequestration and Implementation Planning Office Instructions (ADAMS Accession No. ML16285A005), were provided to you previously in our May 22, 2016, response (ADAMS Accession No. ML16127A186).
