Good morning Maximo,

On June 15 (by letter dated June 9, 2016), the NRC received the application requesting revising the certificate of compliance for the Model 435-B. I noticed that the letter does not specifically delineate the changes made to the application and what NNSA is seeking approval for. I will appreciate you send me a road map with the changes (including Section Nos., the type of change, and the rationale for making the change(s)) and a communication stating the action that NNSA is requesting related to the Model No. 435-B. The letter requests "recertification," but since the NRC already issued a certificate of compliance (CoC), the request should be a revision to the CoC (or basis for certification of the CoC, etc.). The applicant, in this case NNSA, should inform the NRC about the type of approval it is seeking (for example, specific changes on authorized contents, approval of changes to analyses, etc.).
