**Unified Agenda of Federal Regulatory and Deregulatory Actions: Semiannual Regulatory Agenda; Chapter 1 of Title 10 of the Code of Federal Regulations (NRC-2016-0044)**

On June 9, 2016, the NRC published its Semiannual Regulatory Agenda (the Agenda) in the *Federal Register* ([81 FR 37465](#)) in accordance with Public Law 96-354, "The Regulatory Flexibility Act," and Executive Order 12866, "Regulatory Planning and Review." The Agenda is a compilation of all rules on which the NRC has recently completed action, has proposed, or is considering action. This issuance of the NRC's Agenda contains 22 active and 27 long-term rulemaking activities: 2 are Economically Significant; 8 represent Other Significant agency priorities; 41 are Substantive, Nonsignificant rulemaking activities; and 1 is an Administrative rulemaking activity. In addition, 3 rulemaking activities impact small entities. The public comment period on the Agenda closes on July 11, 2016.

**Issuance of LaSalle County Station License Renewal Application (LRA) Safety Evaluation Report**

On June 2, 2016, the staff issued the final Safety Evaluation Report (SER) related to the LaSalle County Station, Units 1 and 2, license renewal application, which Exelon Generation Company, LLC, submitted to the NRC in December 2014. The final SER summarizes the results of the staff's safety review of the LRA in accordance with Title 10 of the Code of Federal Regulations, Part 54, "Requirements for Renewal of Operating Licenses for Nuclear Power Plants," and describes the technical details considered in evaluating the proposed operation of the plant for an additional 20 years beyond the term of the current operating license. The staff is scheduled to meet with the Advisory Committee on Reactor Safeguards full committee on July 6, 2016, to discuss the final SER.

**Workshop on Review of License Renewal Applications**

On June 6-10, 2016, the staff hosted a license renewal workshop for Argentina, Brazil, and Mexico to describe key aspects of an NRC license renewal review. The workshop included presentations from the Office of Nuclear Reactor Regulation, Region III, Office of the General Counsel, International Atomic Energy Agency, participating countries, and a guest speaker from industry.
