SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE OF ELECTRIC POWER RESEARCH INSTITUTE TOPICAL REPORT BWRVIP-03, REVISION 18: "BWR VESSEL AND INTERNALS PROJECT, REACTOR PRESSURE VESSEL AND INTERNALS EXAMINATION GUIDELINES"

Dear Mr. Hanley:

By letter dated May 16, 2016 (Agencywide Documents Access and Management System (ADAMS) Package Accession No. ML16161A468), the Boiling Water Reactor Vessel and Internals Project (BWRVIP) submitted an affidavit executed by Mr. Kurt Edsinger, Director, Pressurized Water Reactor and BWR Materials, Electric Power Research Institute, on May 10, 2016, requesting that the information contained in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

BWRVIP-03, Revision 18: "BWR Vessel and Internals Project, Reactor Pressure Vessel and Internals Examination Guidelines," EPRI Technical Report 3002005571 dated December 2015.

A nonproprietary copy of this document can be found in the ADAMS package referenced earlier.

The reasons for requesting withholding of the report are provided in the affidavit.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the version(s) of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, we may send copies of this information to our consultants working in this area. We will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.
