Dear Mr. Hilton:

This refers to the inspection conducted from June 6-9, 2016, at the Global Nuclear Fuel – Americas, L.L.C. (GNF-A) Wilmington, North Carolina facility. The purpose of the inspection was to determine whether activities authorized by the licensee were conducted safely and in accordance with Nuclear Regulatory Commission (NRC) requirements. At the conclusion of the inspection on June 9, 2016, the inspector discussed the findings with you and members of your staff.

Areas examined during the inspection included fixed site and transportation physical protection programs for special nuclear material of low strategic significance, physical protective measures implemented as required by NRC Orders for Interim Compensatory Measures dated June 17, 2002, and Safeguards Information protection. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. There were no violations identified.

In accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) 2.390, "Public inspections, exemptions, requests for withholding," of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room, or from the Publicly Available Records (PARS) component of NRC's Agencywide Documents Access and Management System (ADAMS); accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html> (the Public Electronic Reading Room).
