


\$142,673.00 and (2) providing incremental funding in the amount of \$44,120.00 from \$97,396.00 to \$141,516.00. Accordingly the Agreement is modified as follows:

The Statement of Work remains unchanged.

The new Authorized Cost Ceiling is \$142,673.00.

This modification provides incremental funding in the amount of \$44,120.00, thereby increasing the total obligations for this Agreement from \$97,396.00 to \$142,673.00.

All other terms and conditions remain unchanged.

This agreement is entered into pursuant to the authority of the Energy Reorganization Act of 1974, as amended (42 U.S.C 5801 et seq.). This work will be performed in accordance with the NRC/DOE Memorandum of Understanding dated November 24, 1998. To the best of our knowledge, the work requested will not place the DOE and its contractor in direct competition with the domestic private sector.
