Hello NRC FOIA Department Representative,

Please find attached a Freedom of Information Act Request for:

In speaking with a NRC FOIA Representative, Monarch inquired as to the best way to refine the FOIA request for this location, so to target only select information in the overall NRC file on this facility. Monarch was told an email accompanying the FOIA request would assist in further narrowing the FOIA focus, as there are several categories of documentation that appear for this facility including nuclear medicine, radiology, hospital contacts, etc.

Monarch has already reviewed documentation available on the ADAMS Public Database which is from approximately 2000 to present and determined that documentation available for the subject site does not apply to the target information sought by this FOIA. Monarch then noted that potentially thousands of pages of documents are present in the Public Legacy Database Search for this facility. Specifically, Monarch is seeking to FOIA only documentation related to the Medical Waste Incinerator, which operated from approximately 1965 to 1995. Monarch is seeking copies of all Medical Waste Incinerator file documentation including any applications, permits, certifications, licenses, inspections, citations, agreements, field reports or any other data involving the operational parameters for the subject Medical Waste Incinerator. Monarch has been in contact with Region V (Chicago) NRC Representative, Mr. Michael LaFranzo who indicated that following his cursory review of available documentation for the subject facility, medical waste incinerator documents are on file and could be obtained through FOIA. At this time, Monarch has been informed by Beaumont Health, the new owner of the former Botsford Hospital, that no records or documents for the subject incinerator were identified or retained by the hospital.
