(Violations and Corrective Actions) 10 CFR 20.1302(b) states, in part, that a licensee shall show compliance with the annual dose limit in 10 CFR 20.1301 by demonstrating by measurement or calculation that the total effective dose equivalent to the Individual likely to receive the highest dose from the licensed operation does not exceed the annual dose limit. Contrary to the above, between April 17, 2014, and November 18, 2015, the licensee did not demonstrate by measurement or calculation that the total effective dose structed surveys to determine dose from licensed operations did not exceed the annual dose limit. Specifically, the licensee had conducted surveys to determine dose rates in unrestricted and controlled areas, but did not perform the necessary evaluations to demonstrate that individuals accessing areas adjacent to the controlled area would not exceed the dose limit to members of the public in accordance with 10 CFR 20.1302. The RSO stated that he would ensure the evaluations were performed and documented.
