In accordance with 10 CFR Part 70, Section 70.32 (i), NFS has determined that the changes reflected in the attached Revision 20.A do not decrease the effectiveness of the Emergency Plan, and an amendment of SNM License 124 is not requested. As information, these changes became effective on January 1, 2016.

Since the facility is no longer a Category III Security facility, a dedicated security element is not required. As a result, NFS has revised the affected page in Chapter 1 and the affected page in Chapter 2 of the Plan, and is submitting them per the requirements of Reference 1. The revised pages are attached, in addition to a revised Pen and Ink/Attachment Revision Page 14 that describes the Revision 20.A changes. Changes are also noted by vertical lines in the right margin of the affected pages.
