This refers to your license amendment and change of control contained in the letter received April 25, 2016. Enclosed with this letter is the amended license.

In the letter dated April 25, 2016, SPEC GROUP PSC requested written consent by the U.S. Nuclear Regulatory Commission (NRC) to a direct transfer of control of the above license to you. From your letter, we understand that this transfer did not result in any change to the licensed location of use, materials, or persons using licensed material.

Based on the above understandings, as more fully detailed in the enclosed NRC staff's Safety Evaluation Report, which documents the NRC staff's safety review of the request, the NRC consented to the transfer. Based on the above understandings, the NRC consents to the direct transfer of control of NRC Materials License No. 06-15099-01. NRC approval must be received prior to implementation of the proposed change.
