Supplement to Request for License Amendment:
Core Reference Report Incorporation (LAR-16-001S2)

Ladies and Gentlemen:

Pursuant to 10 CFR 52.98(c) and in accordance with 10 CFR 50.90, by letter ND-16-0053, dated January 29, 2016 [ADAMS Accession Number ML16029A476], Southern Nuclear Operating Company (SNC) requested an amendment to the combined licenses (COLs) for Vogtle Electric Generating Plant (VEGP) Units 3 and 4 (License Numbers NPF-91 and NPF-92, respectively). The requested amendment proposed to depart from approved AP1000 Design Control Document (DCD) Tier 2 information (text, tables, and figures) and involved Tier 2* information (as incorporated into the Updated Final Safety Analysis Report (UFSAR) as plant-specific DCD information), and also involved changes to the plant-specific Technical Specifications (PS-TS) and the associated PS-TS Bases document. The original request contained Enclosures 1, 2, 3, and 4. By letter ND-16-0549, dated April 8, 2016 [ADAMS Accession Number ML16099A284], SNC supplemented the license amendment request with necessary information to implement the original requested changes with correction to PS-TS 3.2.1 in Enclosure 5.

SNC has determined that further clarification of the incorporation of the Tier 2 and Tier 2* information in WCAP-17524-P-A, Revision 1, AP1000 Core Reference Report, which received NRC approval on February 19, 2015 (see ML15015A571) is needed. SNC will incorporate the blue text added and remove the red boxed text deleted by WCAP-17524-P-A verbatim into the VEGP 3 and 4 UFSAR for UFSAR Chapters 1, 4, 6, 12, and 15. Additionally, all figures updated by WCAP-17524-P-A will be incorporated into the VEGP 3 and 4 UFSAR in their entirety, unmodified, except UFSAR Figure 4.2-8, which was redrawn to remove stray marks but without changing the content of the figure, provided in WCAP-17524-P-A. UFSAR Figure 4.2-8 was updated and incorporated into the UFSAR by LDCR-2015-063 and will remain as presented in UFSAR Revision 5.0, submitted June 17, 2016 by letter ND-16-0838.

Enclosure 1 (including the Significant Hazards Consideration determination and environmental considerations for the proposed changes), Enclosure 3, and Enclosure 4 of the original request are not impacted by this supplemental information. Enclosure 5 of the supplement to the original request is not impacted by this supplemental information.

SNC requests NRC staff approval of the license amendment by July 15, 2016, to support future licensing actions that are dependent on the incorporation of the core reference report into the licensing basis. Thus, delayed approval of this license amendment could result in a delay of future licensing activities and associated dependent construction activities. SNC expects to implement this proposed amendment within the VEGP Units 3 and 4 TS and UFSAR within 90 days of approval of the requested changes.

This letter contains no regulatory commitments.

In accordance with 10 CFR 50.91, SNC is notifying the State of Georgia of this LAR by transmitting a copy of this letter to the designated State Official.

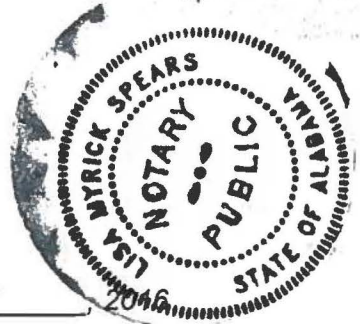
