INSPECTION REPORT NO. 99901379/2016-201, AND NOTICE OF  
NONCONFORMANCE

Dear Mr. Marcos:

Thank you for your June 30, 2016, letter in response to the Notice of Nonconformances (NON) that were discussed in the subject U.S. Nuclear Regulatory Commission (NRC) inspection report.

We have reviewed your letter and have two questions related to your response to NONs 99901379/2016-201-01, 99901379/2016-201-02, and 99901379/2016-201-03. Specifically:

1. Your response to NONs 99901379/2016-201-01 and 99901379/2016-201-02 states that as part of your corrective actions that will be taken to avoid further noncompliance, Equipos Nucleares, S.A (ENSA) will perform "stand down" of several activities. Please clarify what is meant by the term "stand down."
2. Your response to NON 99901379/2016-201-03 states that as part of your corrective actions performed to avoid further noncompliance, ENSA will prepare and deliver to its suppliers a package documentation to facilitate correct understanding of Title 10 of the *Code of Federal Regulations* (10 CFR) Part 21 and Appendix B to 10 CFR Part 50 requirements. Please provide a detailed description of what the package documentation will include and what does ENSA expect its suppliers will do with this package documentation.

If you request that such material is withheld from public disclosure, you must specifically identify the portions of your response that you seek to have

withheld and provide in detail the bases for your claim (e.g., explain why the disclosure of information will create an unwarranted invasion of personal privacy or provide the information required by 10 CFR 2.390(b) to support a request for withholding confidential commercial or financial information). If safeguards information is necessary to provide an acceptable response, please provide the level of protection described in 10 CFR 73.21 "Protection of Safeguards Information: Performance Requirements."
