We reviewed your letters TJT:16:006 dated January 26, 2016, and TJT:16:007 dated January 27, 2016, transmitting the summary of facility changes and the revisions to the integrated safety analysis summaries for calendar year 2015, respectively. Our review of your submittal determined that the changes were made in accordance with the requirements of Title 10 of the *Code of Federal Regulations* (10 CFR), Part 70.72, and did not identify any changes that would require prior U. S. Nuclear Regulatory Commission (NRC) approval. We have no further questions at this time; however, an inspection may be performed at a future date, in accordance with our inspection schedule.
