On June 25, 2015, a partially closed pre-submittal meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and AREVA Inc. (AREVA) representatives. The purpose of this meeting was for the AREVA representatives to discuss with the NRC staff plans for a topical report (TR) for use of chromia-doped fuel in boiling water reactors. The AREVA representatives informed the NRC staff of AREVA's intent to license codes and methods to be used for chromia-doped uranium oxide in fuel reloads, the strategy for developing and licensing those codes and methods, and outlined information to be included in the TR. AREVA intended to use the NRC feedback to modify the TR prior to formal submittal.
