**C-10 Research and Education Foundation, Inc.: Petition for Rulemaking (PRM); Denial; Part 72 of Title 10 of the Code of Federal Regulations (10 CFR) (Docket No. PRM-72-6; NRC-2008-0649)**

On June 24, 2016, the NRC published a document in the *Federal Register* ([81 FR 41258](#)) announcing denial of remaining requests 4 and 9 of PRM-72-6, dated November 24, 2008, filed by Ms. Sandra Gavutis, Executive Director of C-10 Research and Education Foundation, Inc. (the petitioner). The petitioner requested that the NRC amend its regulations concerning dry cask safety, security, transferability, and longevity. The petitioner made 12 specific requests. The NRC previously denied 9 of these requests, accepted 1 request for consideration in the rulemaking process, and two remaining requests were reserved for future rulemaking determinations (77 FR 63254; October 16, 2012). The docket for the petition, PRM-72-6, was closed on June 24, 2016.

**Revision of Fee Schedules; Fee Recovery for Fiscal Year 2016: Final Rule; 10 CFR Parts 9, 170, and 171 (Regulation Identifier Number 3150-AJ66; NRC-2015-0223)**

On June 24, 2016, the NRC published a final rule in the *Federal Register* ([81 FR 41171](#)) amending the licensing, inspection, special project, and annual fees charged to its applicants and licensees and, for the first time, the NRC is recovering its costs when it responds to third-party demands for information in litigation where the United States is not a party ("Touhy requests"). These amendments are necessary to implement the Omnibus Budget Reconciliation Act of 1990, as amended, which requires the NRC to recover approximately 90 percent of its annual budget through fees. This final rule is effective August 23, 2016.
