To accurately reflect the organization that stores and handles licensed material under the SUC-1380 license issued to the U.S. Army Joint Munitions Command, we request amendment of the license for the following:

- Reference item 10.A. Replace Letterkenny Army Depot with Letterkenny Munitions Center. Letterkenny Munitions Center is physically located on the Letterkenny Army Depot as a tenant organization. The location is still Chambersburg, Pennsylvania.
- Reference item 10.A. Replace Anniston Army Depot with Anniston Munitions Center. Anniston Munitions Center is physically located on Anniston Army Depot as a tenant organization. The location is still Anniston, Alabama.

We also request revision of the SUC-1380 license application. On page 3-2, paragraph 3.b., please replace the current sentence with the following:

b. Successful completion of the 40-hour, U.S. Army Basic Radiological Safety Course (4JF2), and the 40-hour, U.S. Army Advanced Radiological Safety Course (4JF3).
