NOTIFICATION OF UPCOMING MEETINGS TO DISCUSS DEVELOPMENT OF THE  
U.S. NUCLEAR REGULATORY COMMISSION'S STRATEGIC PLAN FOR FISCAL YEARS  
2018 THROUGH 2022 (STC-16-056)

**Purpose:** To provide notification of two upcoming meetings to solicit input from State and Tribal stakeholders to inform the development of the U.S. Nuclear Regulatory Commission's (NRC) Strategic Plan for Fiscal Years (FY) 2018 through 2022.

**Background:** The NRC invites you to provide input to help shape the future direction of the agency. The NRC is beginning the process of developing its next Strategic Plan, covering FY 2018 through 2022. The NRC's Strategic Plan will describe how the agency intends to achieve its two strategic goals: (1) to ensure the safe use of radioactive materials and (2) to ensure the secure use of radioactive materials. The plan will identify key challenges and long-term strategies, establish performance expectations, and provide the basis for the annual agency budget and performance plan.
