First Amendment to Standby Trust Agreement

This amendment is entered into as of June 16, 2016 and made in accordance with paragraph 15 of the Standby Trust Agreement dated October 3, 2012 by and between E.I. du Pont de Nemours and Company, a Delaware corporation, herein referred to as the "Grantor," and J.P. Morgan Chase Bank, N.A., a national bank, the "Trustee" for the purposes of Grantor to provide assurance that funds will be available when needed for decommissioning activities required by a materials license (License Number 07-13441-2) issued pursuant to 10 CFR Part 30 by the U.S. Nuclear Regulatory Commission (NRC).

The Grantor, the Trustee, and NRC hereby agree to modify the Standby Trust Agreement as follows:

to: COST ESTIMATES FOR REGULATORY AASSURANCES DEMONSTRATED BY THIS AGREEMENT - \$1,236,150.00.

The cost estimates listed here are approved upon acceptance of this amendment by NRC.

Certificate of Resolution is replaced with the Certificate of Resolution attached herein.


Except as provided in this First Amendment, the terms of the Standby Trust Agreement shall remain in full force and effect.






