Currently our Radiation Protection Surveillance Program is active. We perform daily routine and non-routine radiological surveys to include swipe tests, dose rates, and air

sampling. We decon and free release contaminated motors. We receive radioactive material shipments. Rad-waste is accumulated and then shipped offsite quarterly. Timken provides annual training to all of our Rad-workers. And each Rad-worker is monitored with Dosimetry, as well as, multiple areas of our facility and site perimeter. All radiological release surveys receive as a minimum, a 10% QA check to verify conditions.

The only change being made is our legal name. For instance, we will not be changing personnel or management. There will be no sale or change in assets.
