On June 14, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Diablo Canyon Power Plant, Units 1 and 2, and the NRC inspector discussed the results of this inspection with Mr. J. Nimick, Senior Director, Nuclear Services, and other members of your staff. The inspectors documented the results of this inspection in the enclosed inspection report.

The NRC inspectors did not identify any findings or violations of more than minor significance.
