SUBJECT: SUMMARY OF THE FEBRUARY 3, 2016, PUBLIC MEETING WITH
DOMINION VIRGINIA POWER TO DISCUSS NORTH ANNA
COMBINED LICENSE APPLICATION TOPICS

On February 3, 2016, a Category 1 public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and Dominion Virginia Power (Dominion) regarding the North Anna Unit 3 Combined Operating License Application submitted on December 18, 2013.

The topics for discussion during this meeting included the "North Anna Unit 3 Seismic Audits 1 and 2 Action Item Tracking List - Updated 1/28/2016" (Agencywide Documents Access and Management System Accession No ML16202A475), along with discussions on NRC staff general questions and other general administrative issues related to the ongoing safety review of the North Anna 3 application. The staff presented Dominion with a list for discussion

The meeting commenced at approximately 2:00 p.m. with NRC staff opening remarks, an introduction of attendees, and an announcement of meeting logistics. The following issues were discussed:

- Dominion planned to submit revised Final Safety Evaluation Report (FSAR) markups with respect to discussions about local intense precipitation to FSAR Section 2.4.2 by mid-February.
- Dominion would submit draft responses to Requests for Additional Information (RAIs) 01.05-5 and 02.05.04-26 within the next two weeks.
