SUBJECT: WITHHOLDING PROPRIETARY INFORMATION FROM PUBLIC DISCLOSURE - SUBMITTAL OF PRESENTATION MATERIALS ENTITLED "NUSCALE INTEGRAL JET IMPINGEMENT SHIELDS AND PIPE WHIP RESTRAINT (ISR) AND CONTAINMENT EVACUATION SYSTEM DESIGN," REVISION 0, FOR USE DURING CLOSED MEETING ON JULY 27, 2016 (PROJECT0769)

Dear Mr. Bergman:

In a July 14, 2016, letter (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16200A396), NuScale Power, LLC, (NuScale) requested that the proprietary version of the following presentation slides be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- "NuScale Integral Jet Impingement Shields and Pipe Whip Restraint (ISR) and Containment Evacuation System Design," Rev 0, (ADAMS Accession No. ML16200A393).

A nonproprietary copy of the presentation slides has been placed in the U.S. Nuclear Regulatory Commission (NRC) Public Document Room and added to ADAMS at the following accession number:

- "NuScale Integral Jet Impingement Shields and Pipe Whip Restraint (ISR) and Containment Evacuation System Design," Rev 0, (ADAMS Accession No. ML16200A392).

The affidavit stated that the submitted presentation slides should be considered exempt from mandatory public disclosure due to the proprietary nature of the information contained in the slides. We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure. Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, we may send copies of this information to our consultants working in this area. We will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.
