In your letter dated July 19, 2016, you requested that the U.S. Nuclear Regulatory Commission (NRC) provide federal concurrence for *Part H* to the Suggested State Regulations for Control of Radiation, Radiation Safety Requirements for Non-Healing Arts Radiation Generating Devices (RGD).
