REVISED NRC STAFF EXHIBIT LIST

Pursuant to the Commission's Scheduling Order of July 14, 2016, the staff of the U.S. Nuclear Regulatory Commission hereby provides in the Attachment to this filing its revised exhibit list for the mandatory hearing for Levy Nuclear Plant Units 1 and 2. The Staff made a clarifying revision to the graphic on slide 7 of its Safety Panel. Therefore, the Staff is submitting this updated exhibit as "NRC-011-R."

Consistent with the Scheduling Order, Exhibits NRC-001 - NRC-005 and NRC-007 - NRC-012 will be filed electronically through the NRC's E-filing system. Due to the size and number of files in the Levy Nuclear Plant Units 1 and 2 COL application (Exhibit NRC-006A - NRC-006L), it was not practicable to mark the individual application documents or to file them through the NRC's E-filing system. The attached Staff Exhibit List provides the ADAMS accession number for the package of each part (Parts 1-11) of the COL application. These packages include all application documents. The Staff also provided the COL application on CD to the Commission, the Office of the Secretary, and the Office of Commission Appellate Adjudication.

The Staff determined that it needed to make a correction to a statement on p. 32 of SECY-16-0076. The last sentence of the first paragraph of the "Technical Qualification" discussion currently states: "This QA program includes requirements that will be implemented

by the applicant's engineering, procurement, and construction contractor, Westinghouse and Shaw." Consistent with the evaluation in the Staff's FSER, that sentence should be revised to state: "This QA program includes requirements that would be implemented by the applicant's engineering, procurement, and construction contractor."
