SUBJECT: SUMMARY OF THE APRIL 7, 2016, PUBLIC MEETING WITH
DOMINION VIRGINIA POWER TO DISCUSS NORTH ANNA
COMBINED LICENSE APPLICATION TOPICS

On April 7, 2016, a Category 1 public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and Dominion Virginia Power (Dominion) regarding the North Anna Unit 3 Combined Operating License Application submitted on December 18, 2013.

The purpose of the meeting was to discuss action items related to the Fuel Seismic audit held in March 2016, request for additional information (RAI) 04.02-1, and general discussions of NRC staff questions and other general administrative issues related to the ongoing safety review of the North Anna 3 application.

The meeting commenced at approximately 2:00 p.m. with NRC staff opening remarks, an introduction of attendees, and an announcement of meeting logistics. The following issues were discussed:

- Based upon the recent audit that took place from March 23 through 25, 2016, Dominion presented a slide discussion regarding the fuel related seismic issues related to RAI 04.02-1 that were raised by NRC staff, "Follow-Up Questions to March 23-25, 2016 Fuel Audit".
- Based on discussions and the recent audit, Dominion stated that they planned to supplement their responses to RAI 04.02-1 and submit revised technical reports and FSAR mark-ups accordingly. A schedule was yet to be determined.
