Enclosed is a copy of the final revisions to R313-19-13 and R313-22 of the Utah Administrative Code (Radiation Control Rules) as approved by the Utah Waste Management and Radiation Control Board. Final revisions to R313-19-13 and R313-22 were approved by the Board on June 9, 2016 with an effective date of June 10, 2016. Based on comments received from the NRC (November 13, 2015 ML15300A211), additional amendments were made to R313-19-13 and R313-22 in order to incorporate NRC's requested changes. For convenience, the November 13, 2015 letter and compatibility comments are attached.

The final rules for R313-19-13 and R313-22 are enclosed as well as the associated publication information from the July 1, 2016 edition of the *Utah State Bulletin* which documents final rulemaking action by the Utah Waste Management and Radiation Control Board. The enclosed final rules with the NRC requested revisions are identified by line-in/line-out text and highlighted in yellow. The enclosed rules correspond to the following equivalent amendments to NRC's regulations.
