To Whom It May Concern:

This letter is to inform you that Floyd Memorial Hospital and Health Services, Materials License 13-12371-01 ("Floyd"), has executed an Asset Purchase Agreement with Baptist Healthcare System, Inc. ("Baptist") whereby Floyd will sell all of its assets to Baptist (the "Transaction"), including those assets used in the operation of Floyd Memorial Hospital, an acute care hospital located at 1850 State Street, New Albany, Indiana 47150, including those assets and activities conducted pursuant to the above-referenced License. The parties anticipate that this transaction will close on October 1, 2016. As of October 1, 2016, Floyd Memorial Hospital will be operated as an unincorporated operating division of Baptist Healthcare System, Inc. and will be known as Baptist Health Floyd. In connection with the Transaction, the parties request consent to transfer Floyd's Nuclear Materials License to Baptist. The parties do not anticipate that the Transaction will result in change in the constraints, conditions, requirements, and commitments on the above-referenced License. Representatives of Floyd and Baptist will work together to complete the Appendix F for submission as soon as possible.
