Discussion: Miller contacted Jose Arroyo, Radiation Safety Officer, to confirm that he was aware that J.P. Morgan Chase Bank had served notice that they would no longer be the trustee for the Baxter Healthcare trust agreement, effective August 8, 2016. Mr. Arroyo confirmed that he was aware of the notification and that his treasury personnel were working on consummating a new Trust Agreement prior to August 8, 2016 with Citi Bank. He stated that after the new Trust Agreement was established, Baxter Healthcare would be able to submit the rest of the requested information required for Decommissioning Financial Assurance licensing action. Mr. Arroyo agreed to contact Mr. Miller if there was any difficulty establishing the Trust Agreement before the August 8, 2016 date.
