FEDERAL REGULATIONS PART 72 LIST OF APPROVED SPENT
FUEL STORAGE CASKS: HOLTEC INTERNATIONAL, INC., HI-
STORM UNDERGROUND MAXIMUM CAPACITY CANISTER
STORAGE SYSTEM, CERTIFICATE OF COMPLIANCE NO.
1040, AMENDMENT NO. 2 (RIN 3150-AJ80; NRC-2016-0155)

Enclosed for your signature is a direct final rule, along with a companion proposed rule (Enclosures 1 and 2), amending the U.S. Nuclear Regulatory Commission's spent fuel storage regulations by revising the Holtec International, Inc., HI-STORM Underground Maximum Capacity (UMAX) Canister Storage System listing within the "List of approved spent fuel storage casks" to add Amendment No. 2 to Certificate of Compliance (CoC) No. 1040. Amendment No. 2 adds new fuel types to the HI-STORM UMAX Canister Storage System and updates an existing fuel type description. Additionally, Amendment No. 2 updates Table 3-4 of Appendix B of the CoC to reflect correct terminology and makes editorial changes to Appendix B of the CoC to clarify the description of the top surface pad.
