Update to Transcript Correction Procedures: Final Rule; 10 CFR Part 2 (RIN 3150-AJ76; NRC-2016-0117)

On July 20, 2016, the NRC published a final rule in the *Federal Register* ([81 FR 47005](#)) amending its regulation that governs the correction of official transcripts for agency adjudicatory proceedings. The current regulation has not been substantively updated since it was adopted in 1962, and the NRC's internal procedures have evolved since that time to incorporate technological development. This final rule was effective on July 20, 2016.
