
The purposes of this modification are to (1) Exercise Option Year 5 and, (2) Provide incremental funding.

(1) The Government hereby exercises Option Year 5 (9/26/2016 - 9/25/2017), and the total exercised ceiling is increased from \$5,104,678.87 by \$1,046,923.21 to \$6,151,602.08, and the period of performance is revised to read as: March 12, 2012 - September 25, 2017.

(2) Incremental funding is provided in the amount of \$18,000.00, thereby increasing the total obligated amount from \$3,471,817.37 to \$3,489,817.37.
