COMMENTS FROM STATE OF WASHINGTON RE: NUREG-1556, VOL. 16, REV. 1

OPPORTUNITY TO COMMENT ON DRAFT NUREG-1556, VOLUME 16, REVISION 1, "CONSOLIDATED GUIDANCE ABOUT MATERIALS LICENSES: PROGRAM-SPECIFIC GUIDANCE ABOUT LICENSES AUTHORIZING DISTRIBUTION TO GENERAL LICENSEES" (STC-16-050)

We have only two comments:

Pg. 9-2 of Section 9.1 – No mention of lock-out tag-out procedures for generally licensed fixed gauges. This information should be included in the licensee's application to be able to service generally licensed fixed gauges in their possession.

Section 11 – Why not apply the thirty day notification timeline to amendment requests for change of control or bankruptcy? Specifying a time frame would help prevent loss of control of generally licensed devices during changes in control or administration of licensees.
