On June 16, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your South Texas Project Electric Generating Station, Units 1 and 2 and the inspector discussed the results of this inspection with Mr. Gerald Powell, Executive Vice President and Chief Nuclear Officer, and other members of your staff.
