

- 1) Exercise Option Year 2 for this task order in the amount of \$1,281,202.62, therefore extending the period of performance to 09/25/2017.
- 2) Increase the exercised ceiling from \$2,718,725.78 by \$1,281,202.62 to \$3,999,928.40, fully funding the task order.
- 3) Add incremental funding in the amount of \$51,000.00, thereby increasing the total obligated amount from \$1,766,475.42 to \$1,817,475.42.
