SUBMITTAL OF BAT SURVEY REPORT

The purpose of this correspondence is to transmit the report documenting the bat survey conducted at North Anna Power Station in May 2016.

The northern long-eared bat was listed as threatened under the Endangered Species Act on April 2, 2015. A mist net bat survey was conducted in May 2016 to determine the presence or absence of northern long-eared bats at North Anna Power Station. The survey was conducted in accordance with *2016 Range-wide Indiana Bat Summer Survey Guidelines* (USFWS Guidelines, USFWS 2016) and *Northern Long-eared Bat Interim Conference and Planning Guidance* (NLEB Guidelines, USFWS 2014). No northern long-eared bats were captured during the study. The survey concluded that the species is either absent, or present at such reduced capacity, that the effects from activities associated with the North Anna Unit 3 project will be insignificant and discountable. The bat survey report is provided in Enclosure 1.
