SUBJECT: BROWNS FERRY NUCLEAR PLANT, UNITS 1, 2, AND 3 – REQUEST FOR
WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE
(CAC NOS. MF6741, MF6742, AND MF6743)

Dear Mr. Shea:

By letter to the U.S. Nuclear Regulatory Commission (NRC), dated July 27, 2016 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16210A501), Tennessee Valley Authority submitted an affidavit dated July 12, 2016, executed by Mr. Thomas E. Ryan, Manager, Product Licensing, AREVA Inc. (AREVA), requesting that the information contained in the following document (Enclosure 2 of the letter dated July 27, 2016) be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.390:

ANP-3495P, Revision 1, "Response to RAI [Request for Additional Information] for Browns Ferry Nuclear Plant EPU [Extended Power Uprate] Submittal – SFSP [Spent Fuel Storage Pool] Criticality Safety Analysis, Round 2" (Proprietary version)

A non-proprietary version of document ANP-3495NP, Revision 1 (Enclosure 3 of the letter dated July 27, 2016), is available under ADAMS Accession No. ML16210A501.

The AREVA affidavit dated July 12, 2016, stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

6. (b) Use of the Information by a competitor would permit the competitor to significantly reduce its expenditures, in time or resources, to design, produce, or market a similar product or service.
- (c) The information includes test data or analytical techniques concerning a process, methodology, or component, the application of which results in a competitive advantage for AREVA.

- (d) The Information reveals certain distinguishing aspects of a process, methodology, or component, the exclusive use of which provides a competitive advantage for AREVA in product optimization or marketability.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.


