SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE
THE JULY 21, 2016, MITSUBISHI ELECTRIC SUBMISSION (TAC NO. MF4882)

Dear Mr. Remley:

By letter dated July 21, 2016 (Agencywide Documents Access and Management System Package Accession No. ML16229A116, Mitsubishi Electric Corporation (MELCO) submitted an affidavit dated July 21, 2016, by Hideki Matsui, QA Manager, Energy Systems Center, requesting that the information contained in the documents listed in the enclosure to this letter be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390.

MELCO stated that it did not plan to submit nonproprietary versions of the documents. The basis given was that, because of the extensive amount of proprietary information in the document, nonproprietary versions would be of no value to the public.

MELCO detailed the reasons for withholding the information the affidavit.

The U.S. Nuclear Regulatory Commission (NRC) staff has reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, has determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the version(s) of the submitted information marked as proprietary will be withheld from public disclosure under 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, the agency may send copies of this information to its consultants working in this area. The NRC staff will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.

If the basis for withholding this information from public inspection should change in the future such that the information could then be made available for public inspection, you should promptly notify the NRC staff.

You also should understand that the NRC staff may have cause to review this determination in the future, for example, if the scope of a Freedom of Information Act request includes your
