EOS System, Revised Response to Questions 3-2 and 4-1 from the Second Request for Additional Information (Docket No. 72-1042, TAC No. L25028) (AREVA submittal E-

45191, transmitted to the NRC on June 13, 2016).

This submittal provides a complete revision of the Safety Analysis Report (SAR) and the Technical Specifications (TS) to include a small number of changes made based on recent discussions with NRC materials and thermal discipline staff on June 28th, July 14th and July 18th. Enclosure 2 provides a list of the changes made to the TS and SAR, with a brief reason for the change. Enclosures 3 and 4, herein, provide a complete update to the proposed Certificate of Compliance (CoC) and TS, respectively. No changes were made to the CoC from that provided in Revision 6 in the Reference. Enclosure 5 provides the proprietary version of a complete revision to the SAR application, denoted as Revision 7. The public version of Revision 7 to the application is provided as Enclosure 6. Revision 7 changes are tracked with italicized text and revision bars in the right margin to provide NRC staff reviewers with a convenient way to identify the changes made since Revision 6.

Enclosure 5 of this submittal includes proprietary information, which may not be used for any purpose other than NRC staff review of the application. In accordance with 10 CFR 2.390, an affidavit (Enclosure 1) is provided, specifically requesting that you withhold this proprietary information from public disclosure.

This submittal is being provided as an electronic submission, using the optical storage media (OSM) provision from Section 4 of the NRC Guidance for Electronic Submissions to the NRC. Accordingly, we have included a Document Components listing and OSM#1 and OSM#2 listings at the end of this cover letter.
