This refers to your license amendment request dated July 5, 2016. Please find enclosed Amendment No. 1 authorizing the new storage location and removal of the previous storage location. The facility at 402 Vocational Road, Stallings, West Virginia may be released for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14) and 10 CFR 51.22(c)(20).
