**NRC Enforcement Policy: Policy Revision; Issuance; Chapter 1 of Title 10 of the Code of Federal Regulations (NRC-2016-0134)**

On July 22, 2016, the NRC published a document in the *Federal Register* ([81 FR 47689](#)) that revises its Enforcement Policy to reflect the new maximum civil penalty amount the agency can assess for a violation of the Atomic Energy Act of 1954, as amended (AEA), or any regulation or order issued under the AEA. By interim final rule published on July 1, 2016 ([81 FR 43019](#)), the NRC changed this amount from \$140,000 to \$280,469 per violation, per day, as mandated by the Federal Civil Penalties Inflation Adjustment Act Improvements Act of 2015. This action revises the Enforcement Policy so that dollar amounts in the policy correspond to the agency's revised civil penalty amount, and also provides guidance regarding instances where the NRC may exercise discretion in mitigating the amount of a civil penalty. This policy revision is effective on August 1, 2016.

**Category 2 Public Meeting with Industry on the Pilot Component Design Bases Inspections**
