Subject: IMPOSTION OF CIVIL PENALTY - \$21,000

This is to inform the Commission that an Order Imposing a Civil Monetary Penalty in the amount of \$21,000 will be issued on or about August 8, 2016, to Plus, LLC (Plus). On May 3, 2016, a Notice of Violation and Proposed Civil Penalty (NOV/CP) in the amount of \$42,000 was issued to Plus, based on three willful Severity Level (SL) III violations involving the company's failure to have NRC licenses to distribute, possess, and import byproduct materials. Plus responded to the NOV/CP in a letter dated May 10, 2016, and requested mitigation of both significance of the violations and the proposed civil penalty amount.

Based on the information provided in the response, the staff concluded that there was not a compelling basis to overturn the agency's determination of significance of the violations. Therefore, the significance of these violations will remain at SL III. The staff also concluded that Plus provided new information regarding its small entity classification status as a basis for the mitigation of the proposed civil penalty amount, and the staff concluded that it was appropriate to reduce the civil penalty amount to \$21,000.

Accordingly, an Order Imposing Civil Monetary Penalty in the amount of \$21,000 will be issued on or about August 8, 2016. Under the terms of the Order, the licensee may, within 30 days of the date of the Order, pay the civil penalty, request for alternate dispute resolution, or request a hearing.

It should be noted that the licensee has not been specifically informed of the enforcement action.
