## General Comment

BLM Comments:

1. When the term "Core area" (for Greater Sage-grouse) is used, the currently used term is General Habitat Management Area; GHMA (for non-core) & Priority Habitat Management Areas; PHMA (in-core). As the project is all outside core, I would suggest editing this to either read, GHMA or non-core/GHMA so that agency terms are interchangeable.

2. Table 4-7, pg. 4-59 should include Greater Sage-grouse timing limitations/spacial buffers.

3. Section 5.1.1, pg. 5-3 may wish to include the large-scale Oil & Gas projects currently in Alternatives development just south of your project area.

--Converse County Oil and Gas Development Project
