ORDERED, that the Guernsey County citizens shall have up to and including Monday, January 25, 1999, within which to file a response to the SMC and staff answers; and it is


FURTHER ORDERED, that SMC and the staff shall have up to and including Monday, February 8, 1999, within which to file any reply to the Guernsey County citizens response.
