### Thanks Alicia,

If you could also restate your determinations for the various Federally listed species in your letter, it would be helpful in order to move forward and completer our consultation on the project. The Service finds that the project will result in adverse effects for the Florida panther, so we will be initiating formal consultation for that species. For the American crocodile, the intent of asking for all those protective measures was to have a project that would not result in adverse effects or incidental take of the crocodile. With the proposed fencing and crossings located between the cooling canals system and the test canals, I think we are almost there. The only additional protection measures I can think of that are needed would be: 1) speed bumps and a slow speed limit (i.e., 25 mph) located along the roadway used to access the spoil storage area proposed in the southern portion of the cooling canal system; and 2) pre-land clearing surveys of the Unit 6 and 7 construction footprint to ensure that crocodiles are not located in the footprint during construction. If a crocodile is observed in the construction footprint, all construction activities should be immediately stopped and the not allowed to resume until the the crocodile has moved out of the construction footprint by its own volition. Its your determination, but I believe that the Service can concur with a may affect, not likely to adversely affect determination for the crocodile for this project.
