SUMMARY			
The licensee had submitted a letter dated March 28, 2016 (ML16117A276) which: 1) retracted a decommissioning plan submittal under licensee letter dated June 8, 2015 (ML15162A026); and 2) to provide a technical basis regarding why a decommissioning plan, pursuant to 10 CFR 30.36(g)(1), is not required.  Based upon the information provided, the NRC has requested the following additional information to support the licensee's contention that a decommissioning plan is not required and to bound the conditions where a decommissioning plan could be required. These are:  1. A statement by the licensee that decommissioning activities will cease under the license if any activity in the soil or other material that will remain on site post decommissioning/remediation activities exceeds values found in Appendix B screening values of NUREG-1757 Vol. 1 Rev 2 for either the nuclides of concern or any other isotope found until such time as both the licensee and NRC are satisfied that a decommissioning plan is not warranted;  Continue on Page 2  ACTION REQUIRED (IF ANY)

- 2. A statement by the licensee that decommissioning activities will cease under the license if any internal or external doses associated with decommissioning operations exceeds or could exceed 10% of values found in 10 CFR Part 20 until such time as both the licensee and NRC are satisfied that a decommissioning plan is not warranted;
- 3. The licensee provides procedural work plan(s) on the remediation of any soil, concrete or other material that is to be left in place at the site and not shipped off as radioactive waste; and
- 4. The licensee provides a procedural work plan(s) on any soil, concrete or other material on the characterization of waste to be generated and shipped off to an authorized waste recipient;

The NRC is also requesting the following:

- 5. The licensee provides a procedural work plan of how waste shall be transported/disposed of to include, but not limited to, solid, liquid and mixed waste; and
- 6. The licensee provides a procedural work plan regarding the implementation of the Final Status Survey pursuant to 10 CFR 30.36(j) to include, but not limited to, the type, quantity, and form of radioactive material and in what material (concrete, soil, etc...) to be left at the site.

The licensee committed to providing responses to items 1-4 on or prior to August 26, 2016. The licensee may need additional time to respond to items 5-6.
