Dear Mr. Bush:

By letter dated August 6, 2009, the U.S. Department of Energy (DOE) submitted a draft Long-Term Surveillance Plan (LTSP) for the Umetco Minerals Corporation's (Umetco's) Gas Hills East site in Natrona and Fremont counties Wyoming (Agencywide Documents Access and Management System (ADAMS) Accession Number ML092250176). The U.S. Nuclear Regulatory Commission (NRC) provided comments on this and subsequent drafts of the LTSP, but, due to tailings pile cover construction and groundwater issues at the Gas Hills East site, the NRC and DOE staffs agreed in 2014 that the NRC staff would suspend our review of the draft LTSPs until the issues were resolved. Currently, issues associated with the cover have been resolved, but the NRC is continuing to work with Umetco to resolve groundwater issues at the site. We believe that when the groundwater issues, and any other issues that may surface during our ongoing review, are resolved, the DOE should submit a new draft LTSP for the Gas Hills East site. This new draft LTSP would incorporate any changes necessitated by new information developed for the site and reflect the most recent information developed about the groundwater hydrology at the site.
