This refers to your license amendment request dated July 7, 2016. Please find enclosed Amendment No. 94 authorizing the addition of Sarah O'Connell, M.D. as an authorized user for 10 CFR 35.100, 35.200, and oral administration of greater than 33 millicuries of sodium iodide-131.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
