SUMMARY The U.S. Nuclear Regulatory Commission (NRC) staff (Mr. David Drucker) and a representative of Northwest Medical Isotopes,			
LLC (Ms. Carolyn Haass) held a telephone call on August 3, 2016, to discuss and clarify the Northwest Medical Isotopes, LLC (NWMI) responses to NRC staff's request for additional information (RAI) concerning the NWMI Construction Permit Application environmental review. On July 18, 2016, NWMI submitted responses to NRC staff's RAIs (ADAMS No. ML16210A305). The NWMI RAI responses that were discussed during the August 3, 2016, telephone conference call included: POSA3-1A, POSA3-1B, POSA3-2A, NOI3-1B, PA3-1, and POS3A-3. Regarding the responses to POSA3-1A, POSA3-1B, POSA3-2A, Mr. Drucker asked questions to better understand the responses and Ms. Haass stated that minor editorial revisions to the responses would be submitted on the docket to the NRC. Regarding the responses to NOI3-1B and PA3-1, Mr. Drucker stated that the responses did not address the RAI sufficiently. Ms. Haass stated that revised responses to these two RAIs would be developed from other publicly available documents (ML16110A253 and ML16146A213) and would be submitted on the docket to the NRC. Regarding the response to RAI POS3A-3, Mr. Drucker stated the response was not sufficient. Ms. Haass agreed to address this RAI at the public meeting scheduled for August 11, 2016, at NRC HQ.
